

Frequently asked questions

1. **Is there an initiation fee:** Yes, there is an initiation fee for all members joining after 12/31/25. The initiation fee is \$750 for all members excluding junior members. This initiation fee does not apply to returning members who pay before 3/31/26.
2. **Is the driving range included:** Yes, the driving range is included for all members in all classes
3. **Are carts mandatory** – Yes, carts are mandatory for all members on Fridays, Saturdays, Sundays, and Holidays until 2pm from the Opening Day event until 9/30/26. Any other day or after 2pm on the days above any member can walk at no extra fee.
4. **Is there a food minimum or utilization fee:** Yes, there is a utilization fee that runs for the calendar year of membership, meaning January - December. The fees are as follows: \$750 for the individual class of age 25-29 only, \$1,250 for the age 25-29 family class only, \$1,000 for all individual members, \$1,500 for households, \$500 for socials, junior members are excluded from utilization fees. If you do not spend your utilization, you will be billed at the beginning of January the following year and the payment will be due by 1/31 of the following year. If we do not hear from you to pay by check, we will run the balance through your credit card on file on or about January 31st. Failure to pay this balance or credit card issues will be considered breach of contract and steps may be taken at the magistrate level for payment.
5. **What counts toward my utilization fee:** Guest fees, guest passes, food, drinks (including alcohol), and cart fees. Pro shop merchandise does not count toward your utilization fee.
6. **What constitutes a junior:** Any child wishing to join the junior membership class must be between the ages of 14-24. Any junior under the age of 14 will be evaluated on a case-by-case basis by the committee and golf professional. Any member of a household up to the age of 24 is also considered a junior and must follow any junior restrictions.

Juniors do not have to pay for a cart if they play with a full paying member up to age 16. As soon as the junior turns 16, he/she must start paying for carts.

7. **Do Junior members have any restrictions:** Yes, a junior is restricted on Fridays, Saturdays, Sundays, and Holidays from playing until after 2pm. This restriction can be waived provided a junior member is playing with a full paying member and age 14 and older. Monday – Thursday there are no junior restrictions. Juniors under the age of 14 must follow all junior restrictions.

Juniors are not permitted to play in certain club events, such as the member/member or member/guest. All juniors can play in the club championship provided they play in the Championship Flight only. No juniors will be allowed in the other Club Championship flights.

8. **What constitutes a Non – Resident:** A non-resident is considered anyone living 25+ miles from their house to Hannastown Golf Club at 441 Blank School Rd Greensburg, PA 15601. This will be verified using Google maps only, taking the shortest route by mileage regardless of toll roads. A driver's license will be required of anyone wishing to be part of this membership class on an annual basis.

24.9 miles does not constitute a non-resident; it must be 25+ miles.

There are no restrictions on playing times or club events for non-resident members.

9. **What constitutes a Household:** Households can be any husband/wife, husband/wife/junior, boyfriend/girlfriend, boyfriend/girlfriend/junior, same sex couples, same sex couples/junior living in the same household. Driver's licenses may be requested for verification purposes to prove they live in the same household. Children are only considered household members up to and including age 24. If they turn 24 in the member year, they can be part of the household membership but must change to a new membership class the following year. No restrictions for household members over the age of 24 except for certain club events such as the Men's Member Guest.

Any grandparent, parent, or uncle/aunt who wishes to bring a grandchild, child, nephew/niece to play or use the range may do so at no cost to the member for anyone under 14. Once the child turns 14, they need to join as household members or junior members.

10. **What constitutes a Social Member:** A social member can play up to 54 holes per month and pay discounted greens fees. Those fees are \$60 per 18 holes and \$35 per 9 holes. Club events will count towards a social member rounds per month so please plan accordingly if you wish to participate in club events.

11. **Can a Golf Professional play in club events:** Yes, a golf professional can play in the club's premier events, which are the club championship, the member/member, and the member/guest, but they are not allowed to accept prize money or pro shop credit. The golf professionals' weekly tee games and other club events will be at the discretion of the committee and golf professional.
