# HANNASTOWN GOLF CLUB

## 2021 OUTSIDE EVENTS POLICY AND CONTRACT

### Event Deposit

- ❖ A **\$200.00** non-refundable deposit must accompany the signed contract to reserve the day of event. **Note: Deposit will be applied against the final event cost.**

### Final Payment

- ❖ Hannastown does not carry accounts. All costs must be settled in full on the day of event.

### Golf Packages

- ❖ Monday – Thursday: see attached sheet for package pricing
- ❖ Saturday – Sunday: see attached sheet for package pricing

### Food and Beverages

- ❖ No person or group may bring food or beverage to Hannastown Golf Club.
- ❖ All event food must be purchased from the menu included as part of this contract.

### Events

- ❖ Minimum of 60 participants are required to hold a shotgun start Monday – Thursday  
**(You will be required to pay for 60 players if you fail to meet the minimum)**
- ❖ Minimum of 80 participants are required to hold a shotgun start Saturday – Sunday  
**(You will be required to pay for 80 players if you fail to meet the minimum)**
- ❖ Hannastown Golf Club recommends holding Events on Mondays
- ❖ In the event your requested date is unavailable, the club will suggest alternative dates.
- ❖ If Hannastown Golf Club is unable to accommodate any of your desired dates, deposit will be returned.
- ❖ Shotgun starts Monday – Thursday @ 9:00am or 1:00pm
- ❖ Shotgun starts on Saturday & Sunday @ 2:00pm
- ❖ If fewer than 60 Players are participating, tee times will be required.
- ❖ Total count for all golfers & meals needs to be emailed [hannastowngcp@comcast.net](mailto:hannastowngcp@comcast.net) or faxed 724-836-1180 to Hannastown 5 days prior to your event.

### Dress Code

- Metal spikes are expressly prohibited.
- All players must wear shirts with collars. *Note: Mock neck collars are acceptable.*
- Blue jeans or Sweat Pants are not considered acceptable attire.
- Hats must be worn with bills facing forward.

**The dress code shown above will be enforced. Those inappropriately dressed may purchase compliant apparel from the Hannastown Pro Shop or will not be permitted to play.**

## Additional Outing Information

- ❖ All outings are required to designate an **Outing Sponsor**. The individual shall represent the interests of the group, provide primary communication to Hannastown Golf Club, and represent all contractual obligations set forth in this Outing Contract.
- ❖ All groups of 25 or greater are considered outings at Hannastown Golf Club. All outings are subject to Hannastown Golf Clubs' Rules and Regulations and Outing Rules. A \$200.00 deposit is required to secure the requested date and time of your outing. All potential outings not providing a deposit, are at risk for losing the requested date and time to other parties.
- ❖ All outings are required to provide a final count of participants, as designated in the contract agreement, no less than 5 days prior to the event. Please refer to this agreement for participant number specific to your outing. This ensures the maximum use of Hannastown's facilities to all patrons. Any change in outing numbers subject to the parameters described in this agreement.
- ❖ The golf course will only be "closed" for shotgun outings with 60+ golfers (Mon-Thur) or 80+ golfers (Sat-Sun) participating.
- ❖ The Outing Sponsor will be responsible for any damage to the golf course, equipment, and/ or club property. It is this person's responsibility to advise all outing participants of Hannastown Golf Club's Rules and Regulations - provided in the Outing Packet.
- ❖ The Outing Sponsor is required to schedule all Food & Beverage services for the day of the outing. All activities relative to food and beverage services associated with the outing will be handled by Hannastown Golf Club. Outside food and alcoholic beverages are not permitted on Hannastown Golf Club property. Donated non-alcoholic drinks are allowed, but must be approved by Hannastown Golf Club. A food and beverage package are required for all shotgun start events.
- ❖ All outings canceling 60 days or more from the scheduled date are provided a full refund on deposits, with the exception of any custom merchandise orders already processed through the manufacturer.
- ❖ Any outings cancelling less than 60 days from the scheduled date are subject to full forfeiture of deposit.

- ❖ In the event of inclement weather, Hannastown Golf Club management reserves the right to limit the use of golf carts and/or deem the course unplayable. As this is an important decision, it will be one not made in haste, and every effort will be made to go forward with your event as planned.
- ❖ Should the golf course be deemed unplayable, rain checks will be offered to participants, to be redeemed any weekday, or weekend after 12:00PM, in lieu of rescheduling the golf portion of the event. Any obligations for scheduled food and beverage services must be honored on the original day of the event. If play has commenced, and more than nine holes have been completed, the outing is deemed complete.
- ❖ The Outing Sponsor is required to provide a **final roster and pairing sheet** to the Golf Professional no less than **5** days prior to the event (as stated in the contract agreement specific to the outing).
- ❖ All hole signage and/or outing banners must be supplied to Hannastown Golf Club no less than **48 hours** in advance of the outing.

**Any exceptions to the above rules require prior approval by the Hannastown Golf Club management. Management shall decide any matter not resolved by this contract.**
